We are helping our clients across the country, and internationally, answer the key questions raised by these new orders:

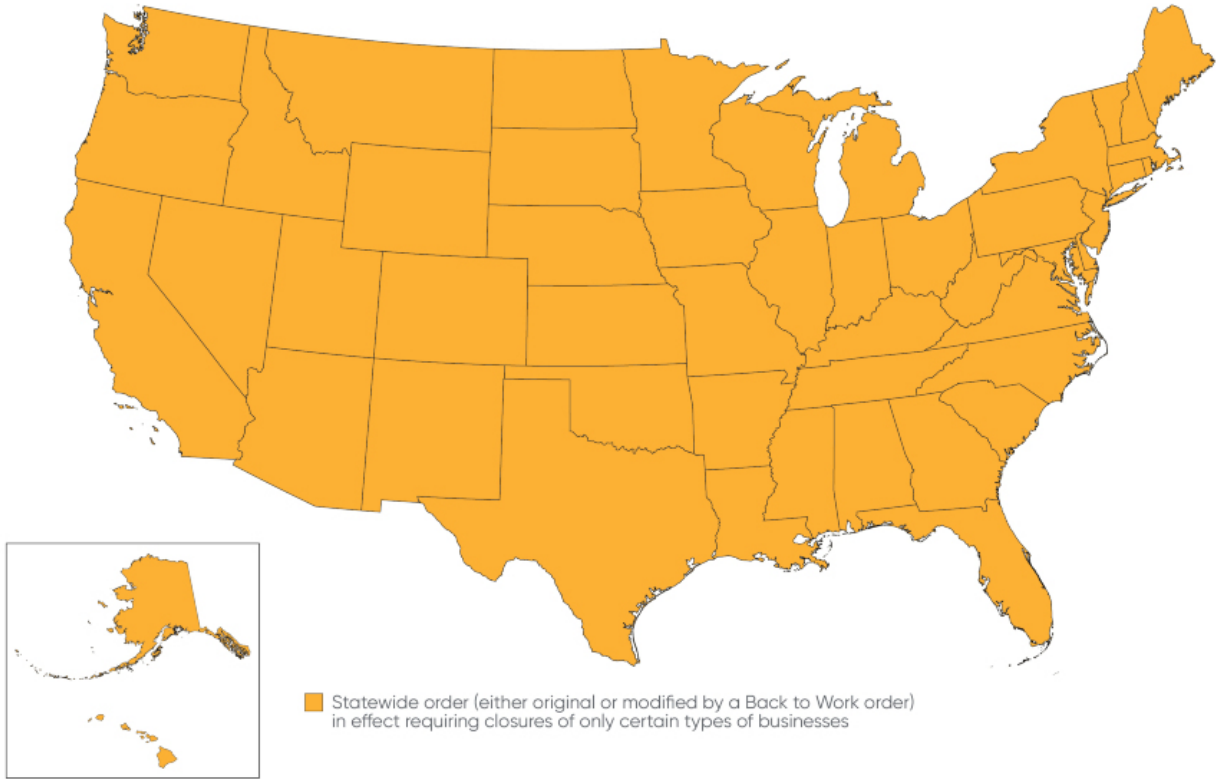
- Can I continue to operate some or all of my facilities?

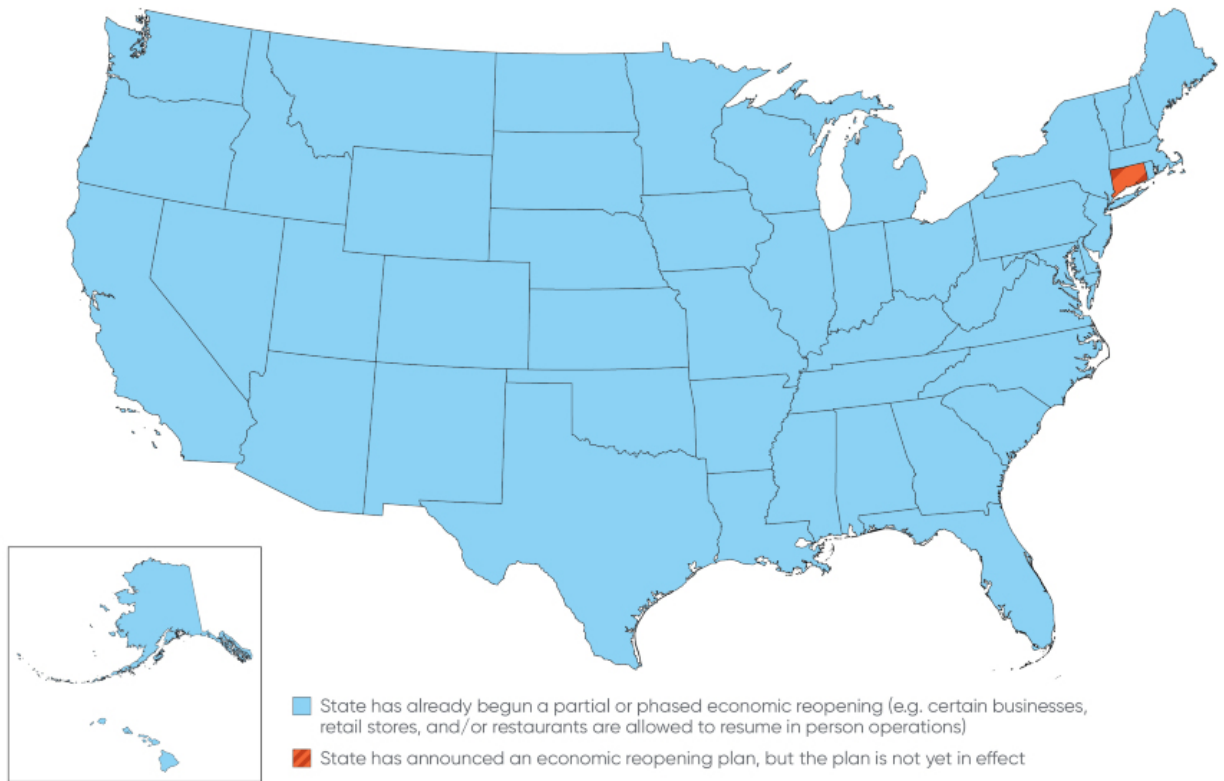
